### **Sign Permit Fees**

Except as specifically excluded from the provisions of the Nicholson Sign Ordinance, it shall be unlawful for any person to post, display, substantially change, or erect a sign in the city without first having obtained a sign permit. A permit can be obtained by the filing of the following application and payment of the required fee. The application should be filed with the City Clerk and may be filed in person at Nicholson City Hall, 175 Lakeview Drive, Nicholson, GA 30565 or by mail at PO Box 365, Nicholson, GA 30565.

The fee for a sign permit is assessed in accordance with the following table, based on the size of the proposed sign:

<b>(a) 1-32 square feet</b>	<b>\$32.00</b>
<b>(b) 33-64 square feet</b>	<b>\$64.00</b>
<b>(c) 65-100 square feet</b>	<b>\$100.00</b>
<b>(d) 101 to 128 square feet</b>	<b>\$128.00</b>

Incomplete applications for applications which lack the fee or any required documentation will not be accepted. Permit fees are non-refundable. While the City Clerk will attempt to assist applicants in filing their applications with the proper documentation and required information, it is the responsibility of the applicant to ensure that the application is complete and accurate.
