**Minutes:** Mike motioned to approve the November 6, 2017 Council Meeting Minutes; Max seconded. All were in favor. **Motion approved.**

**NEW BUSINESS:**

**Speed Limit Signs – Radarsigns** – Mike motioned for the city to purchase two Radarsign speed limit signs, for a total of \$7501 including accessories. Max seconded. A unanimous vote was taken. **Motion approved.**

**Surplus Property** – Mike motioned to release the cities old dump truck as surplus property, Max seconded; a unanimous vote was taken. **Motion approved.**

January Council Meeting: Jan mentioned to council members that the first Monday in January is New Year's Day and the city is closed. Mike motioned to move the January Council Meeting to Tuesday, January 2, 2018, Max seconded. **Motion approved.**
